

Two successful candidates for County Clerk did not get to vote for themselves Nov. 8, because illness kept them indoors. They were Kenna Clark, Marion county, and Frank Thorne, Wirt county.

Mr. Clark was taken ill several days before the election and was bedfast on that all-important day. However, he didn't need this extra vote, as his majority was more than substantial.

At the same time Mr. Thorne was a patient in the St. Joseph's hospital, Parkersburg, with a badly infected finger. For more than two weeks before the election he did not get to do any campaigning, but he won reelection by (Continued on Page Two)

#### HAMPSHIRE'S FIRST DIVORCE IN 1773

Husband Returns to Find Spouse Re-Married; Spurns Revenge

Hampshire county's first divorce—and probably one of the first granted in what is now West Virginia—resulted from peculiar circumstances.

During Pontiac's war, prior to 1757, a farmer living in Hampshire county was taken prisoner by the Indians, but his wife esaped. He was carried to Ohio and sold from tribe to tribe until several years afterwards, when peace was made with the Indians and he came home.

Great was his disappointment when he learned that his wife had long ago given him up as dead, had re-married and had several children by her second husband. Instead of seeking revenge, he had the following paper recorded in Deed Book No. 3, page 161: (Actual names omitted for obvious reasons)

reasons) "To all whom these Presents shall come or may concern Whereas my Wife Barbara formerly Barbara D\_\_\_ sometime left me & hath intermarried with James C.\_\_ do therefore hereby certify that I do freely acquit & discharge the said James & Barbara from all Trouble or Damages by means of their Intermarriage & do consent that they may dwell & cohabit together as Husband & Wife for the future without any Interruption from me. Given under my Hand & Seal this XIX Day of February 1773 "Test





The document, with names omitted for obvious reasons, was sent to The NewsTeller by Miss Pauline Snyder, Hampshire county deputy clerk, and is reproduced as follows:

"Be it known to all to whom it may concern that I W\_ \_of the county of Hampshire and Commonwealth of Virginia do by these presents liberate emancipate and forever set free from and after the day of my death my negroe woman Nancy on condition that she remain with me during my natural life in the quality of my wife In witness whereof I have hereunto set my hand and affixed my seal this 6th day of May in the year of our Lord one thousand eight hundred and twenty six


