

COMMITTEE TO EQUALIZE CLERK'S FEES

By A. R. Martin, President County & Circuit Clerks' Ass'n of the State of West Virginia.

It has been the practice in the offices of many County and Circuit Clerks to continue a set charge for filing and recording various papers without due consideration to fees as listed in the Code of West Virginia.

For instance, some Clerks probate a will and make the appointment of executor for \$2.00 or \$3.00, while others charge \$4.00, \$5.00, or as much as \$8.00 for this work. The price of recording additional pages or excess words to a deed or other paper is plainly set out by the Code, but not all Clerks follow it.

These are only suggestions as to many differences which should not exist and which have been discussed at the Annual Clerks' Conventions. Last year a resolution was passed authorizing the president of the Association to appoint a committee of three County Clerks and three Circuit Clerks to suggest the proper fees to be charged, and to make a re-

port at our annual meeting at Beckley to be held in June. Following this resolution, the president appointed the committee as follows: Paul E. Wehrle, Charleston, Chas. P. Furbee, Clarks-burg, Earl S. Wolfe, Parkersburg, M. H. Hix, Charleston, L. L. Nightengale, Wheeling, and Clarence Curry, Fairmont.

This committee will appreciate any suggestions from the Clerks, and it is the wish of the officers of the Association that all clerks assist in this work and make known to the committee the problems to be solved, and in this way furnish many valuable thoughts for consideration.

Circuit Court Fees **Drop During 1939**

Collections Only \$18,639, Clerk M. H. Hix Reports

The Kanawha county circuit clerk's office did less business in 1939 than 1938 with a resultant drop in litigation fee co'lections of from \$21,203.40 to \$18,639.26, Circuit Clerk Malcolm H. Hix re-

"I have known all along that we were doing less business," Hix said, adding, "I guess when times are good fewer people become involved in litigation."

The number of chancery cases instituted fell off from 1,002 to 762 and law cases from 526 to 491. There were 430 divorces granted in 1939 as compared to 445 in 1938 and 511 in 1937.

Civil appeal cases from justice of the peace courts decreased from 260 in 1938 to 180 in 1939, state misdemeanor appeals from 350 to 236 and city misdemeanor appeals from city court from 56

There were, however, more pages written into the record books, figures being 3,986 for 1938 and 4,260 for 1939. Subpoenae issued increased from 10,606 to 11.661.







Kanawha Court Head Succumbs

Dr. C. A. Ray Dies Suddenly At Age of 75

Dr. Charles Andrew Ray, 75, president of the Kanawha county court and chief of the Kanawha Valley hospital medical staff, died Jan. 21 of a heart ailment.

He became ill at his Pocataligo home, "Raymont," shortly before Saturday midnight.

Born May 14, 1864, at what is now Kanawha City, he was the son of John E. and Deborah Ray.

Dr. Ray was educated in Kanawha county public schools and taught for several years. He attended the College of Physicians and Surgeons at Baltimore and received a medical degree in 1887. After serving as an interne at Baltimore City hospital he took post-graduate work at Johns Hopkins hospital and New York Polyclinic.

He was elected a fellow of the American College of Physicians in February, 1926. Dr. Ray first practiced at Montgomery and was located in Winifrede for 16 years. After a short stay in Huntington, he practiced at Lewisburg for 16 years. He had practiced in Char-

This amazing story is told by Hugh Brady Perkins, 12-year-old son of Sheriff and Mrs. Floyd Perkins of Summersville, Nicholas county, upon his return home from a hospital bed at Philippi, 105 miles away.

Attracted by a noise at his window, he glanced up from his hospital bed in Myers Clinic to face a New Year's visitor, a pigeon, perched on the window sill.

"That's my pigeon. I know him by his bill," he called to the day nurse. "Let him in."

She tried to put him off thinking it was a dream. It did not seem possible that his pigeon could come from Summersville direct to his room in the hospital.

"I'll bet if you will let him in, you will find a band on him with the number 167. Open the window, let him in and see if he doesn't have a band bearing that number," he pleaded. Seeing she could not be prevailed upon to open the window, he gave up for the time being.

When the night nurse came on, the pigeon was still there. He finally prevailed upon her to open the window. Brady grabbed for the pigeon, almost exerting himself too strenously, as the window was beyond reach of the bed. Sure enough it bore the band with the number 167.

The story was soon known throughout the hospital.

Sheriff Floyd Perkins says that the pigeon came to their home last Fall; that Brady fed it and made a pet of it. It has a peculiarly shaped bill and is banded. He thinks that it is a stray carrier pigeon. Mr. Perkins could not recall just when the pigeon was last seen at home, but he is under the impression that it has been seen since Brady went to the hospital three weeks ago. His deduction is that the bird was on a flight, buffeted by stormy weather and that it just amazingly happened that it landed at the hospital room of its friend.

The wedding ceremony was read in the Manse of the Presbyterian church in Monterey, with the pastor, the Rev. A. E. Johnson, officiating.



Fire Destroys Hinton School

Damage Is Said \$150,000; New Location Sought

Fire which broke out in the basement of the Hinton Central school building at 5 o'clock Jan. 24 destroyed the 14-room brick structure.

The origin was not determined. Mrs. Margaret Nicely Leidig, Summers county school superintendent, said the building was a "total loss." She declined to estimate the damage, but it was "partly covered" by insurance.

Unofficial estimates placed the loss at \$50,000.

The Hinton high school, located nearby and which was threatened by the flames, was dismissed for the remainder of the week.

The Central building was essentially an elementary school, although part of the high school work was carried on there. Also, it was said to contain a quantity of county school records.

Erected in 1895 with a later addition, Central served as the high school building until a new one was constructed in 1925.

There are three other elementary schools in the community.



The condition of Roy J. Virden, clerk of Pleasants county circuit court, who recently underwent surgery in the Camden-Clark Memorial hospital, Parkersburg, is improving slowly.

Court House Addition Planned

Work Will Be Started at Once on Wayne Structure

Plans are being made by the contractors to begin work immediately on the construction of the Wayne county court house addition and walls on two sides of the court house square.

J. G. Lambert, county clerk, said the contractors informed him they had already purchased materials for the work and these will begin arriving at Wayne in the near future.

The contractors, Crouch and Crouch of Beckley, also indicated to county officials that local labor would be used whenever possible. They have already let a sub-contract for the stone work in connection with the foundation and basement of the addition to Boyd Smith of Sidney, it was reported.

Bond of \$10,000 to assure satisfactory completion of the work according to plans and specifications for the addition has been furnished by the contractors through a surety company. The work must be substantially completed within 100 calendar days from Dec. 7.

Under the contract signed by the county court and contractors, Crouch and Crouch will be paid monthly estimates furnished by the architect based upon 90 per cent labor and material in place in the building, and 60 per cent of materials on the building site, subject, however, to a holdback of 10 per cent on each estimate until full completion of the work. Final payment will be due fifteen days after completion of the work.

The contract was awarded to Crouch and Crouch on their low bid of \$12,000.
