Brooke's First Court House Built in 1799

Was Destroyed by Fire and Rebuilt in 1849

(See Front Cover)

The Brooke county court house pictured on the front cover of this issue was built nearly 100 years ago, in 1849. However, it was stuccoed in 1933.

Court records show that the site was purchased from Charles Prather on June 27, 1797, the deed being made to John Beck, a member of the county court.

On April 29, 1799, the court met in session at some other building, then adjourned for 15 minutes to meet at the new court house at Charles Town, which name was later changed to Wellsburg.

The original structure was built by Samuel Herdman who lived to see it replaced in 1849, after it had been damaged by fire.

Henderson Is A Busy Clerk

He and One Assistant Handle Tyler's Affairs

Besides answering hundreds of queries, locating and searching records, issuing licenses, taking acknowledgments and doing small favors generally for the public, County Clerk Ray F. Henderson of Tyler county and his assistant, Mrs. Mary King Klowlton, write and check an average of thirteen pages daily into the records of Tyler county. Of the pages written, eleven are typewritten and two are hand recorded. During the month of May, three hundred and twenty-nine pages were added.

Of the items recorded, deeds of trust, chattel mortgages, relief and records of court proceedings lead the list while the numerous miscellaneous items add to make the grand total. Deeds of trust and chattel mortgages consume over eighty pages while deeds for property occupy twenty-eight.

During the month of May the salaries of Mr. Henderson and his assistant actually cost the tax-payers of Tyler county \$72.05. They received in salary \$268.35 and returned from recording fees into the treasury \$196.30.



Pine Tree Register Has Model Office

New Office of Register of Deeds of Somerset County, Me., One of Most Attractive in State

One of the most efficiently arranged and impressively beautiful offices in the state of Maine is that of Miss Flora G. Caouette, Register of Deeds of Somerset County at Skowhegan. The room is divided into two sections: the library with bookcases, files, library tables and cabinets for reference work; and the Register's office with desks and office machinery for the actual recording of deeds. The other machinery includes two book machines and three typewriters as both bound and loose-leaf books are used for the records.

The simplicity in design and pale green walls give the office a dignified and refreshing appearance. To the eight large windows with venetian blinds are due the excellent ventilation and unsurpassed lighting. All artificial lighting is indirect. Acoustical tiling on the ceiling makes the room sound-proof and climaxes echoes. The floors are covered, for foot ease and comfort, with inlaid linoleum which is made in Maine.

All of the office furniture and equipment is of dark maroon-finished metal, making the entire room fire-proof for the permanent preservation of the records.

Miss Caouette was Clerk in the office of Register of Deeds for fifteen years and when the Register retired she became one of eleven candidates for the office. She won at the primary and in September, 1939, defeated her opponent by a very large majority.

Attorneys from all parts of Maine regard the office of Register of Deeds as one of the best of its kind in the state and contend that it is extremely pleasant to work in.

Some interested veterans are conducting a search for these records. When found some local record will be made that the future may have this valuable data. The World War is little more than 20 years in the past but the records are dim and that trying period has been forgotten by many.

These records when obtained will be of great value to future historians and others interested in Lewis county in the World War.

Jailer Paskel Quits Post After 27 Years

Resignation Will Become Effective July 1

George R. Paskel, who has served as deputy sheriff and jailer of Hardy county for the past twenty-seven years, has tendered his resignation to Sheriff P. D. Delawder. The sheriff has accepted Mr. Paskel's resignation, to become effective July 1, but as yet no appointment has been made to fill the yacancy.

During this long period of faithful service to Hardy county, Mr. Paskel has witnessed happenings in the county which most residents never see and often never hear about. On the other hand, he has been an assisting officer of the law in many of the county's spectacular crimes such as the Shoemaker apprehension by state troopers last year.

The Paskels expect to move from the jailer's quarters in the county jail to their new home on Winchester Avenue by July 1.

MARRIAGES ON DECLINE

According to the records in the cffice of County Clerk Ray F. Henderson, "Getting Married in Tyler County" isn't what it used to be.

During the month of May 1840 five marriages were recorded. The county then had a population of 5,964. Forty years later, in 1880, the same month recorded weddings for eight from a population of 11,086.

The marriage records for May 1940 are still vacant; but Mr. Henderson reports confidentially that there has been one May bride so far in 1940.

Custer Court Clerk Has Unique Hobbies

Mr. Floyd H. Walden of Miles City, Mon., Turns to Prize Poultry, Shaded Penmanship to Relax

"Painless Payment of Taxes" was the unique slogan adopted by Mr. Floyd H. Walden, Clerk of the District Court of Custer County, Montana, when he began his career as a public official in 1932. Upon that slogan he was elected Treasurer of Custer County, being the only one of his party to gain an office open for election during a year when a landslide for the opposing party prevailed in the county.

A World War veteran, serving with the 362nd machine gun company of the 91st division, Mr. Walden studied accounting after the war and served 12 years as a public accountant before running for County Treasurer. While in that office he instigated a new system of accounting, changing the tax set-up, the handling of the school district and high school district accounting to the benefit of the taxpayer, all of which systems are still in use.

Mr. Walden has two strangely unrelated hobbies—shaded handwriting and raising poultry. At present he has the only commercial flock of Black Leghorns in the state of Montana and pursues his hobby with scientific accuracy and method instilled in him thru years as a public accountant and county official. He knows to the fraction of a cent how much his flock costs as to upkeep and is constantly improving the strain and their living conditions.

As to his second hobby, Mr. Walden is constantly requested to write calling cards, inscribe scrolls, grade and high school diplomas, and other official documents for lodges, service clubs and other organizations throughout the county. His flowing signature x x x is recognized likewise

wherever it appears.

Records in the Clerk of Court's office date back to 1879, the county having been organized in 1877, but Montana not being admitted as a state until 1889. In 1865 Custer County was part of Big Horn County, reaching from Canada to Wyoming and from the Dakota Territory to almost the center of the state—one of the largest counties ever to exist in the United States.

At present Custer County—one of 56 in Montana—has an area of 3,741 square miles, almost two and a half times as large as the State of Delaware. Its history is intimately linked with such famed frontier characters as General George Armstrong Custer, General Nelson A. Miles, Calamity Jane,

Wild Bill Hickock, the Marquis de Mores, Teddy Roosevelt and Sitting Bull, Chief Joseph, Rain-inthe-Face, and Red Cloud.

At present Mr. Walden is making a complete audit of all records in the Clerk of Court's office, been done, which is in line with something that had never before his policy of giving every available service to the public.


