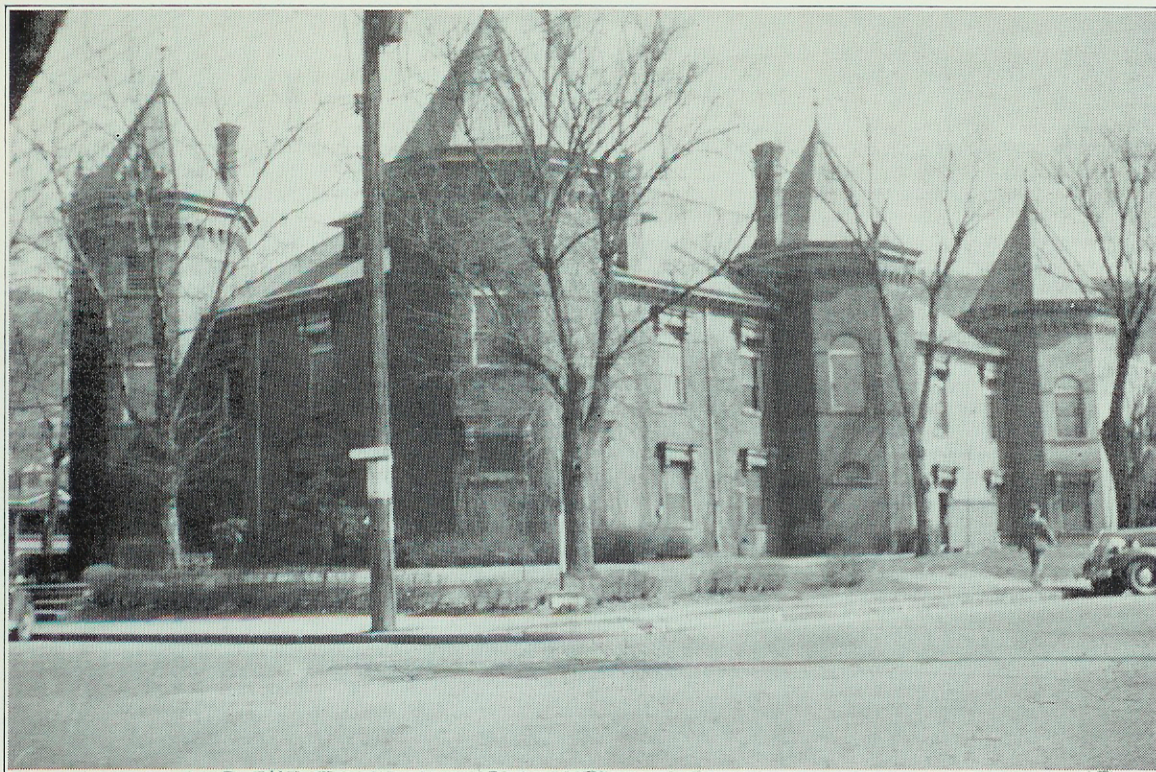

The court house was built in 1874 by Col. J. C. McDonald and a new addition was added in 1924.

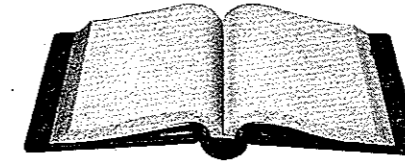

Calhoun Wants New Court House

Special Levy Election to be Held Jan. 14

Voters of Calhoun county will go to the polls Jan. 14 to decide on a special levy which would make possible the construction of a new court house at Grantsville.

It is understood that such a levy would raise approximately \$47,000 and the government will give another \$110,000 to complete the project. Boosters for the levy point out that the present structure is antiquated and too small for modern requirements and they predict that the levy will pass.

Working in connection with the federal government, Calhoun is now constructing one of the most modern jails in West Virginia.

"Be it therefore resolved that we, the members of the grand jury at the regular November term of the circuit court of Wayne county, do commend them:

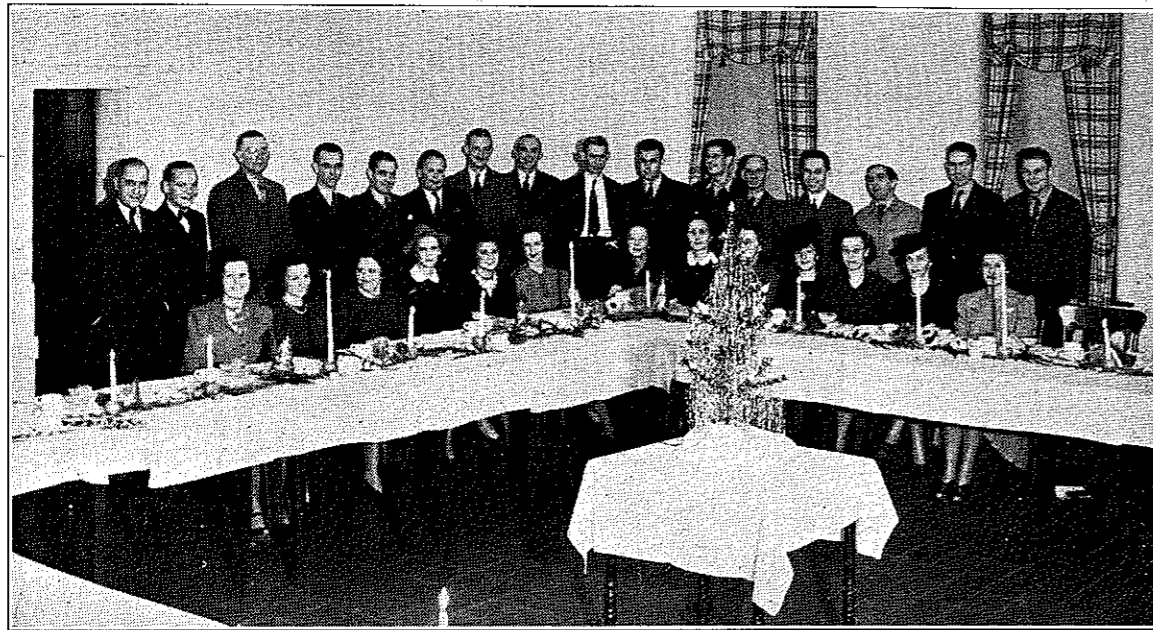
"1. For the splendid manner in which they have performed their official duties throughout the period of four years.

This Sheriff Succeeds Himself

Herbert Traubert Reelected To Brooke Post

Sheriff Herbert Traubert of Brooke county has the unique distinction of being reelected to office, although state law plainly forbids a sheriff from running for reelection.

But Sheriff Traubert did not circumvent the law. Here's how: His father was elected sheriff of Brooke county in 1936. Shortly thereafter he died and son Herbert Traubert was appointed to fill out the vacancy, until the election in 1938. That year he was elected for another two years, to finish the original term of his

father.

Inasmuch as he had never served a full term, the courts held that he was entitled to run for a full four-years, which he did, and he was elected. This probably is one of the few times in West Virginia that a sheriff legally ran for office to succeed himself.

Miss Una Mada St. Clair, daughter of County Clerk and Mrs. Ed St. Clair, of Taylor county, was united in marriage Christmas afternoon to Glenn C. Ireland of Charlottesville, Va. The marriage was performed in the St. Paul's Methodist church at Grafton.

W. A. Myers, member of the Mingo county court, sustained a broken collar bone in an auto wreck several weeks ago, and didn't know it for several days.

The accident occurred at Williamson, but Mr. Myers did not think that he was hurt, other than having been shaken up. Meanwhile his wife went to Washington, D. C., for an operation and while visiting her there, Mr. Myers found that he had broken his collar bone.

Late reports say he is on the mend.

Ernest Garnett is the new deputy county clerk of Gilmer county, succeeding Newt Rymer, who resigned to become head of the draft board there.

Upshur Educator Takes Nat'l Post

Bonar Succeeds Shumaker as Head Upshur Schools

The administrative personnel of the Upshur county schools was changed last month when it was announced that R. Worth Shumaker, county superintendent during the past 8 years, had resigned, and Ross Bonar, principal of the Buckhannon-Upshur City High School, had been named to his position.

Mr. Shumaker resigned his post to accept an educational position of national scope with the American Legion with headquarters at Indianapolis, Ind. The new position, which is appointive, represents a substantial advancement for Mr. Shumaker. On two occasions he has been the Republican party's choice to make the race for the office of state superintendent of schools.

Mr. Bonar will serve the remaining unexpired term of Mr. Shumaker, and by agreement is to be named for a four-year term by the board of education next July.

Mr. Bonar holds his master's degree in school administration from West Virginia University, Morgantown. His academic work was taken in West Virginia Wesleyan College. For 22 years Mr. Bonar has served the schools of Upshur county, first as teacher, then junior high school principal, and for the past seven and one-half years as principal of the large Buckhannon-Upshur City High School. He has been active in the State High School Principals' Association, has served on numerous state committees, and has been very active in all civic, church, fraternal and patriotic organizations of Upshur county.

Former-Sheriff Ralph E. McDonald of Lewis county recently returned from the Huntington veterans' hospital where he had been receiving treatment.

NEW COUNTY CLERK

Only new county clerk in West Virginia since Jan. 1, 1939, is O. H. Carson of Madison, who was appointed as county clerk of Boone county, succeeding Lloyd Estep, resigned. He took office Dec. 1. Mr. Carson had been chief deputy in Mr. Estep's office for several years.

DEPUTY CLERK'S DAUGHTER WEDS

Miss Betty Ann Beddow, daughter of Mrs. Elsie Beddow, deputy circuit clerk of Logan county, and Okey Lucas, son of Mr. and Mrs. B. V. Lucas, were married Dec. 18 in Pikesville by Rev. Wright, a Methodist minister.

Mrs. Lucas graduated from Logan high school last year.

Mr. Lucas also is a Logan high graduate and attended Marshall college. He was an outstanding athlete at Logan and has attained prominence at the latter school.

Mr. Lucas is now employed at the Nickle Plate Plant in Huntington. The couple will make their home there after the first of the year.

Circuit Clerk's Office Has \$2,718 Profit

Income Increase Caused by Requiring Candidates To File Fee

The Kanawha circuit clerk's office last year netted the county a profit of \$2,718.10.

Clerk Malcolm H. Hix reported fees totaling \$23,375.60 as compared with \$18,639.26 the previous year while operating costs during 1940 totaled \$20,657.50.

Hix explained that the increase was largely due to the law requiring candidates for public office to pay a filing fee.

However, chancery cases instituted during 1940 numbered 1,034, an increase of 272 over 1939, and law cases rose from 491 in 1939 to 568 in 1940.

Last year 520 divorces were granted as compared with 430 the previous year and there were 53 adoptions as compared with 29 in 1939. There were 69 changes of names.

Hix said 7,834 names were added to the general index during 1940 and that 4,155 additional pages were written on the record books. Subpoenas issued totaled 9,055 as compared with 11,663 in 1939.

Murder indictments totaled 15 last year, three less than in 1939, and other felony indictments 574, an increase of 49 over the previous year.

Flat Tires

Dirty work at the crossroads is suspected by President Dorcel Wedge, of the Mason county court, who discovered three flat tires when he attempted to drive his car out of his garage recently. Near the scene was a jar full of nails, and it is thought that someone deliberately punctured his tires.

Anyhow, the case has been turned over to state police on the advice of W. H. Rardin, prosecuting attorney.

Sheriff Franklin Deem of Ritchie county was in a party of deer hunters who hunted in Pennsylvania during December.

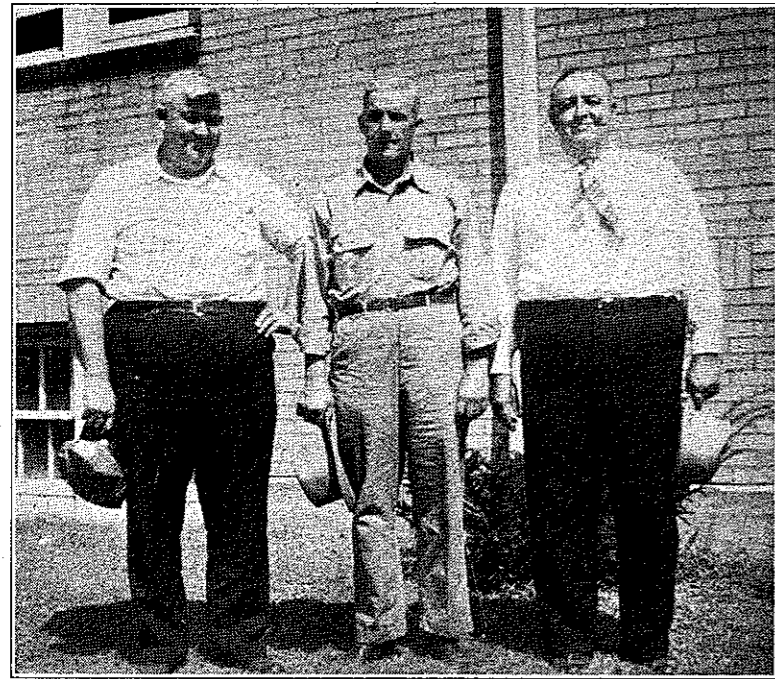

Retiring Sheriff Recalls Unusual Similarity

Sheriff Frank H. Patton of Marshall county, whose four-year term expired at midnight Dec. 31, recalled that his grandfather completed a similar office in a neighboring state 100 years ago "to the hour."

William Patton of Woodsfield, O., was elected sheriff of Monroe county, O., in 1836 for a term of four years which expired Dec. 31, 1840. Patton lived to an advanced age and at his death was buried at Mount Rose cemetery in Moundsville.

Clerk's Son Dies

Kenneth Friend, 15-year-old son of Levy D. Friend, Clerk of the Clay county court, died in a Charleston hospital Jan. 2 after a brief illness of pneumonia.

Fourth Term

J. Blackburn Watts on Jan. 1 began his fourth term as prosecuting attorney of Kanawha county. On the same day J. H. "Toss" Abbott began his third term as assessor of that county.

Gilmer Assessor Takes Over Jan. 1

Lee Taggart to Run Office Himself, He Announces

Gilmer county's new assessor took office Jan. 1, and he is going to run the office himself, except for some extra clerical help during the rush period.

He is Lee Taggart, 42-year-old World War veteran who was elected with a record-breaking majority of 1661. He will have no office deputy, he said, but B. O. Van Horn and Oris Curry will be his field deputies.



It was Assessor Taggart's first bid for public office. He had three opponents in the primary, but romped away with the nomination. Indeed, he had 469 more votes than the other three put together.

Born and reared at Orton, Gilmer county, he was educated in the public schools and volunteered for service in the Navy during the World War. He is married, has a daughter in Glenville college.

His 3,522 votes received in the general election was probably the largest vote ever cast in Gilmer county.

Kentucky Halts Hasty Marriages

Law Requiring Physical Exams, Blood Tests Effective Jan. 1

The last "port of entry" for West Virginians seeking hasty marriages was closed Jan. 1 when Kentucky's new law requiring pre-marital physical examinations and blood tests became effective.

As a result, West Virginia county clerks looked for an increase in the marriage license business during 1941, since there now is no adjoining state where a license may be obtained without either a waiting period or an examination.

The influx of altar-bound West Virginians into Virginia was stopped last August when a law similar to this state's requiring a three day notice and blood test, became effective. Ohio has a five-

day law, Maryland a three-day law, and Pennsylvania a three-day law and blood test.
